

CONTEST NAME: Farm Aid Ticket Giveaway

Contest Official Rules and Prize Details

Eligibility

Contest entrants must be at least 18 years old as of June 22, 2017 and a resident of Pennsylvania, Ohio, West Virginia or Maryland. This contest is sponsored by WQED Multimedia, 5802 Fifth Avenue, Pittsburgh, PA 15213. Employees, board members and advisory committee members of WQED and its licensed stations, Live Nation, and their respective immediate family and household members are not eligible. All federal, state, and local laws and regulations apply. Void wherever prohibited or restricted by law.

Entry Period

The contest period for the Farm Aid Ticket Giveaway is 12:01AM Eastern Daylight Time June 22, 2017, and ends at 11:59 PM Eastern Daylight Time on August 31, 2017.

How to Enter

No purchase or contribution is necessary. Of course, we appreciate contributions, but sending a contribution will not affect your chances of winning. You can enter the contest during the Entry Period only by going to <https://www.wqed.org/farm-aid-giveaway>, and submitting the completed online entry form. Entries received outside of the Entry Period and incomplete entries are void. One set of tickets will be given to one winner.

Prize Package Includes:

Two tickets within the first 10 rows at 2017 Farm Aid Concert Festival on September 16 at the Keybank Pavilion.

Market Value of the Prize is approximately \$400.

Use of Prize. WQED will provide winner with tickets by mail two weeks before the event.
