**MATERIALS SUBMITTED:** Participants agree that all submissions made by them are original and do not in any way infringe on the rights of any third parties. Participants agree that they will not submit any materials containing images or copyrighted material belonging to third parties unless they have a license from those parties to do so. Participants agree that they will not submit any defamatory, obscene or otherwise illegal material. Use of such materials shall disqualify submissions and participant.

**CONSENT TO USE EMAILS:** Participants agree that WQED may use emails provided by participants for WQED membership purposes, including but not limited to general WQED information and other membership opportunities.

**CONSENT TO PERMIT USE OF SUBMITTED MATERIALS BY OTHERS:** Participants agree that by submitting materials for the ONE OF A KIND STORIES they consent to the use of their stories, images, and other materials by WQED and by the ONE OF A KIND STORIES sponsors for promotional, educational, and institutional purposes.

**NO PURCHASE NECESSARY:** No purchase or contribution is necessary to submit a ONE OF A KIND STORY.

**SELECTED ONE OF A KIND STORIES:** Participants agree that, should their story be chosen pursuant to the judging criteria, participants will be required to complete additional consents, releases and other documentation at the request of WQED prior to use of the selected story. Failure to execute all requested documentation will result in withdrawal of offer to showcase the selected story.

**ADDITIONAL CONSENT:** By entering, Participants agree to abide by and be bound by these Terms and Conditions.
