MATERIALS SUBMITTED: Participants agree that all submissions made by them are original and do not in any way infringe on the rights of any third parties. Participants agree that they will not submit any materials containing images or copyrighted material belonging to third parties unless they have a license from those parties to do so. Participants agree that they will not submit any defamatory, obscene or otherwise illegal material. WQED will remove such material immediately and bar the submitting participant from further participation.

CONSENT TO USE EMAILS: Participants agree that WQED may use emails provided by participants for WQED membership purposes, including but not limited to general WQED information and other membership opportunities.

CONSENT TO PERMIT USE OF SUBMITTED MATERIALS BY OTHERS: Participants agree that by submitting materials for the VIRTUAL TREE OF KINDNESS they consent to the use of their stories, images, and other materials by WQED and by the VIRTUAL TREE OF KINDNESS sponsors for promotional, educational, and institutional purposes.

PUBLICATION OF MATERIALS: Participants agree that all submissions will remain posted on the Virtual Tree of Kindness at the discretion of WQED. Participants agree that WQED may remove any submission for any reason.
